- ¹ Except for the puppy classes (ages 4 to 12 months), an original four-generation pedigree **MUST** be a part of the dog's registration papers. A pedigree from the dog's breeder or any other service is **NOT** acceptable.
- ² For hips and elbows, SV certificates are required for the dog's breed survey in order to be registered with the SV; otherwise OFA certificates are acceptable. **Note: For SV hip/elbow certification, the SV requires x-rays on film. If you have only digital pictures, contact USCA for information on how to get the digital pictures transferred to film.**
- ³ All registered score books, other than those issued by WDA, are acceptable.
- ⁴ If your German Shepherd Dog is breed surveyed for 2016-2017, you must present the dog for reselection by December 31, 2017, to be reselected for life. Otherwise, the time period allowed between surveys has been exceeded and the dog must start over with an original survey.
- ⁵ A minimum of a "G" rating is required for a breed survey. **A rating card from the Adult class (24+ mos. untitled) is not acceptable for Breed Survey purposes.**
- ⁶ A new (first) Breed Survey requires an Endurance Test (AD) and at least one performance title (SchH/IPO 1, VPG, HGH, or RH2 -B [IPO-R, -F, -FL, -T, -L or -W]) obtained under a USCA recognized performance judge, and a BH obtained under a WUSV recognized judge. Dogs with an HGH title are not required to have a BH title. Also, it is mandatory that a minimum of 80 points in protection be achieved in SchH/IPO/VPG1. (USCA Breed Survey Regulations as revised March 2015).
- ⁷ For the puppy classes (4-12 months): if you have it, provide a COPY of the puppy's registration certificate; *the four-generation pedigree is not required for classes 4-6, 6-9, and 9-12 months.*
- ⁸ **All dogs shown in classes 12 months of age or older must be:** (1) tattooed and/or have a microchip before entry into the conformation show; (2) registered with a WUSV registry; and (3) registered with the USCA when owned by a resident of the USA. The fee for USCA/SV dual registration is \$104.00 and an application can be completed on the day of show. The original registration papers and the original four-generation pedigree must be submitted with the dual registration application. **If proof of USCA registration is not available or an application for same has not been completed, a \$104.00 deposit will be required on the day of show.** The \$104.00 deposit is refundable once proof of USCA or USCA/SV registration is provided. The fee for USCA individual dog registration only is \$35.00.
- ⁹ The adult class is for dogs older than 24 months of age that do not possess a recognized working title. Dogs can only be shown once in this class during a lifetime, and then must advance to the Working Dog Class.
- ¹⁰ Any dog entered in the working class over 3½ years of age that has not been breed surveyed will not be eligible for a "V" rating.
